### YOUR IRA AND THE CHURCH



If you are over 70 and have a Traditional IRA this announcement may apply to you. According to current tax laws those 70 and over must take a Required Minimum Distribution from their IRA account each year. That amount is subject to tax and is added to your annual income. Did you know that you can avoid paying tax on that minimum distribution? If you send the amount (or a partial amount) to Edinburg United Church you will not owe taxes on the amount. You must have your investment company send the amount directly to the church; if it goes to you then you owe tax on it. You can find more information by clicking here.

### **PASTORS REVIEW**

A review of 2018 would not be complete without taking a step back to examine the entire year. We budgeted for an Associate Pastor position and we began the year awaiting how we might fill that role. A person was put forward but ultimately was voted down. This was for various reasons; but we must rely on our faith that it wasn't the right time, person or move for EUC at that moment. We have no longer budgeted for an Associate Pastor. There seems to be no congregational push or excitement for adding a staff person. As we move into 2019, may we all seek God's vision for the future of EUC. There will be a larger emphasis placed this year on laity leadership for events. We can no longer rely on me to drive fellowships, meetings, events or fundraisers.

The Associate Pastor vote created some temporary hurt feelings and divide within the church. But it did not consume us. We have had an excellent year in terms of growth. Our average attendance is as high as it was in my first year here. We joined 16 new members (including 2 through confirmation). I performed 10 baptisms, 9 funerals and 6 weddings. Edinburg United Church has a total membership of 254.

2019 will bring new faces, new challenges, new opportunities for growth in many aspects. May we embrace the newness of this year and follow where God is leading. Blessings,

# January, 2019 Report—Mortage Balance and Transactions for 2018

Three years ago we began the process of paying off a \$250,000 mortgage. As of December 31, 2018 our mortgage balance is \$151,980.58. Yes, you read that correctly-- almost 40% of our mortgage has been paid off as of 12/31/18.

Last year at the January meeting we voted to make one principal payment from our Apple Pie Profit. It was also decided that we would look into selling our Verizon stock. The stock was sold and we received two checks totaling \$14,184.07 the proceeds of which were applied as a principal payment to the mortgage.

In addition, we were able to make principal payments from both offerings and memorial gifts designated to the Building Fund in the amount of \$23, 489.44.
